Land Acknowledgement

the Anishinabek Nation, the Haudenosaunee Confederacy, and the Huron-Wendat. It is now home to many First Nation, Inuit, and Métis communities. We acknowledge the current treaty holders, the Mississaugas of the Credit First Nation. This territory is the subject of the Dish with One Spoon Wampum Belt Covenant, an agreement to peaceably share and care for the Great Lakes region.

Student Financial Aid Initiative

- Speaking with Marco with Julie, report on the Financial Aid initiative in progress
- Next year's team will have to continue with this initiative due to time constraints.
- Statistics being provided by Admin and students (payment for rent, what they are using bursaries for, etc)

Multiple Complaints from Students in Family Law: Prof Roxanne Mykitiuk

- Requests for compassionate grading policies OR pass/fail options for students given the current situation in her class
- Connecting with Dylan further on this to give details to APPC/Deans and see what can be done.

Multiple Complaints from Students in Copyright Law: Prof Sileshi Hirko

- Requests for access to his lecture recordings (has opted out at the beginning of the term for pedagogical reasons, but in light of the strike, students say that this would be a workable workaround)

- Senate Policy 008 – professors need to record in case for students who are electing to opt out of classes due to the strike
- If you are opting out of going to class? You can get access to the recordings. But, you must elect to opt out of **all** classes or none (cannot pick and choose which classes you want to go to).
- Question: What about a professor who just does not want to record lectures?
 - What happens to students who elect not to go to class & yet the professor does not want to record (i.e. as an imposed, indirect consequence of not coming to class)?
 - Have Associate Dean Scott remind them again to make their best efforts to record for those with accommodations and those who opt-out
 - The professor in this case has been informally spoken with & the email has gone out to all instructors from Associate Dean Scott.
 - Will wait for one more class & see what happens
 - Suggestions from Members that this student collaborate with other students and remind the professor to record their lectures.
