CDO Appointments

- Osgoode 1L students can only meet with the CDO 1x before the recruit, meanwhile, individuals at UofT get up to 4 meetings in the first semester alone.
- Would like to see more specific and tailored advice for questions and for resume/cover letter reviews.
- In comparison to other CDOs from other schools, we need more resources & assistance
- Discussion:
 - Similar issues across years, the best option at the moment is to reach out to upper years for immediate help for resume and cover letter review, interview preps, etc
 - Looking into advocating for better feedback that is constructive for students

Perspective Option Concerns

- Some students do not find these offerings helpful
- Asks: can they have the option to take the Indigenous requirement instead?
- Discussion:
 - The purpose of perspective options is to get you thinking about your interests *outside* of core courses of law school and so you can write the 5K word paper on a topic of interest.
 - Proposed this idea to APPC last year – but, according to student feedback, they enjoy having the option to take at least 1 course of their choosing in 1L (various members of Caucus agree).
 - Would be difficult to encourage additional changes to the 1L curriculum when many changes are being implemented next year after last year's committee on 1L curriculum reform
 - A part of Osgoode's reputation – having more flexibility in the first year of the program is something many other schools do not offer
 - You can also opt for the one course that fulfills the Indigenous Law requirement and paper requirement in 1L if you would like.
